COURSE DESCRIPTION:

This course is intended to provide an overview of Eastern Austronesian languages, particularly those of the Oceanic group. Topics to be covered include: (i) an overview of Oceanic languages and subgrouping hypotheses; (ii) possessive constructions; (iii) noun incorporation; (iv) transitivity and actancy; (v) serial verb constructions; (vi) reduplication.

Data will be drawn from a number of Oceanic languages representing different subgroups and/or different geographical areas.

COURSE REQUIREMENTS:

Term paper presentation (August 5)	40%
Research/Term paper (due August 19)	60%

Grades for this course will be based on one presentation (40%) and one research/term paper (60%).

- **Term paper:** All registrants are expected to write a brief report on one of the following morphosyntactic features of one (or more) Oceanic language(s): (i) possessive constructions; (ii) classifier systems (numeral and/or possessive); (iii) noun incorporation; (iv) transitivity and actancy; (v) serial verb constructions. The paper can also be a comparison of a morphosyntactic feature between one (or more) Philippine language(s) and one (or more) Oceanic language(s).
 - <u>Presentation</u>: 15 minutes for presentation and 5 minutes for Q-A. Please prepare handouts for all participants in the class.
 - <u>Format</u>: All registrants are expected to write a 7–15 (double-spaced) page paper that conforms to the guidelines of *Language* or *Oceanic Linguistics*.

[Note: Examples should be presented in a (single-spaced) three-line format (Line 1—language data (use IPA Doulos 93 or Doulos SIL for phonetic symbols); Line 2—interlinear gloss; Line 3—free translation).]

• <u>Deadline</u>: The research paper is due at **3:30PM**, **Saturday**, **August 19**, **2006**.
